**Announcement relating to Premium Income**

(the "**Company**" or "**CPIC**") today announces that, for the period between 1 January 2024 and 31 August 2024, the accumulated primary premium income of China Pacific Life Insurance Co., Ltd., a subsidiary of the Company, amounted to RMB191.729 billion, representing a year-on-year increase of 1.5% and the accumulated primary premium income of China Pacific Property Insurance Co., Ltd., a subsidiary of the Company, amounted to RMB142.235 billion, representing a year-on-year increase of 7.7%.

2. The accumulated primary premium income of China Pacific Property Insurance Co., Ltd. is the consolidated data including that of Pacific Anxin Agricultural Insurance Co., Ltd., its subsidiary.
